



## Privacy Statement BridgetJ

### PERSONAL DATA WHICH IS PROCESSED

BridgetJ can process personal data about you because you use services provided by BridgetJ, and/or because you fill them in yourself on the contactform on the website of BridgetJ. BridgetJ can use the following personal data:

- Your first and last name
- Your address
- Your telephone number
- Your email address
- Your IP address

### WHY BRIDGETJ NEEDS YOUR PERSONAL DATA

BridgetJ processes your personal data to reach you by telephone if you request BridgetJ to do so, and/or to contact you through written communication (by email or post) if you cannot be reached by telephone. Besides that, BridgetJ can use your personal data to carry out an assignment for you, usually consisting of textual services.

### HOW LONG BRIDGETJ KEEPS YOUR DATA

BridgetJ will not keep your personal longer than necessary to reach the goals your personal data is collected for. Your personal data will not be stored longer than year if we do not reach a business agreement for an assignment.

### SHARING YOUR PERSONAL DATA

BridgetJ only shares your personal data with third parties if this is required to execute the assignment agreed on with you or to meet legal obligations.

### MAPPING WEBSITE VISIT BEHAVIOR

General visitor behavior data is collected on the website of BridgetJ, among which are the IP address from your computer and the time of retrieval and other data your browser sends. This data is used for analysis of visitor and click behavior on the website. BridgetJ uses this information to improve the operation of its website. This data is anonymised as much as possible and is not provided to third parties.

BridgetJ uses functional, analytic and tracking cookies. A cookie is a small tekst file that is stored in the browser of your computer, tablet or smartphone when you first visit a website. BridgetJ uses cookies with a technical funtionality which make sure the websites works properly. They can also be used to optimize the website. Other cookies are placed to track your surfing behavior so BridgetJ can offer custom made content and ads. When you first visited this website, BridgetJ already informed you about these cookies and asked for permission to place them. You can always sign out of the cookie agreement by changing the settings of your internetbrowser so it will no longer save the cookies. It is also possible to delete any previously saved data through the settings menu of your browser.

## GOOGLE ANALYTICS
